Rules Regarding Entry

Entrant must inform AFA delegate of intention to hang, including artist's name, title of work, media and price by January 29, 2010.

To be eligible, a piece must have won an award in a member league's show within the last two years.

Entry must be the piece which won the award. NO SUBSTITUTIONS!

Entry piece cannot be one shown in a previous "Best of the Best".

Only one (1) piece per artist per league.

Entry fee of \$20.00 must be paid when piece is brought in for hanging at Mayslake Peabody Estate.

Each league/guild may enter up to ten (10) works of art.
(This number may be increased, if other leagues/guilds do not enter their ten pieces.)
